After attending a Spinning Babies® Certified Parent Educator Workshop

- You may call yourself a Spinning Babies® Certified Parent Educator and use the corresponding badge in your website and advertisements.
- Use the corresponding badge in your website and advertisements. After the first use of the full title, you may use SpBCPE later in the text/conversation.
- Website or Blog: Please write out the full words "Spinning Babies" and add the registered trademark logo to Spinning Babies® for each use on any post, public

document, or promotion. If possible, superscript the registered trademark logo, but we understand that some web editors do not allow you to do this. If you are sharing our website, please use this format (capitalize the first S and B): SpinningBabies.com

- Parent Educator Class: As a Spinning Babies® Parent Educator or Certified Parent Educator, your three-hour class is called "Spinning Babies® Parent Class". In a longer course or series in which you include the Spinning Babies® Parent Class module, use your business name and/or the name of your course as the title. In the description of the course say "including the Spinning Babies® Parent Class module". Remember your badge on your advertisements.
- Promotions or Advertisements: Spinning Babies® Approved Trainers, Spinning Babies® Aware Practitioners, and Spinning Babies® Certified Parent Educators are allowed to advertise our arrangements in their services, such as Spinning Babies® Three Principles: Balance, Gravity, and MovementSM, The Three BalancesSM, or The Pelvic Levels SolutionsSM. SpBCPEs and Aware Practitioners can offer the services for which their agreement allows.
